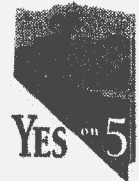

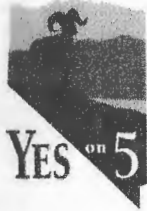

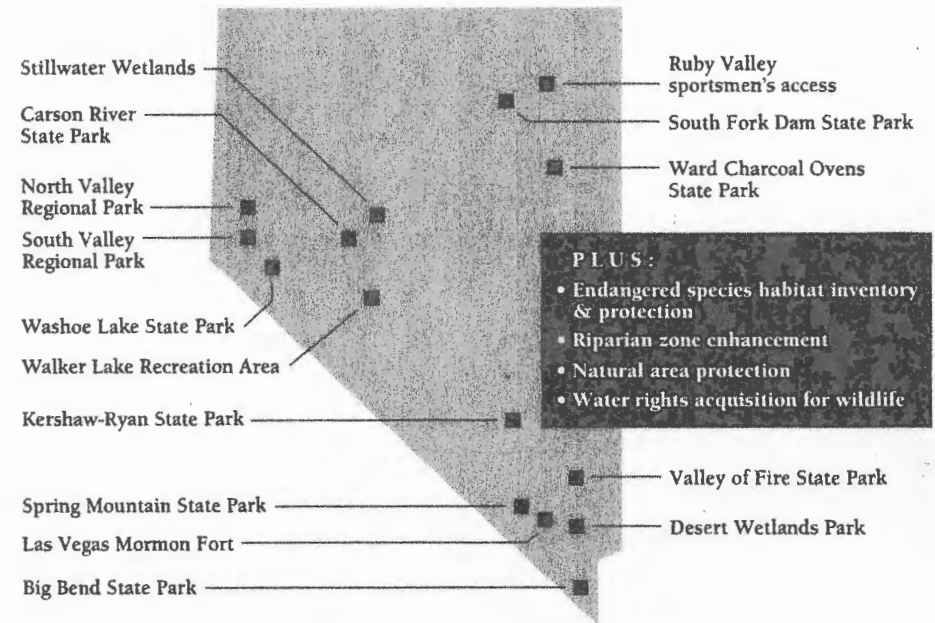
On November 6th, Nevadans will have a chance to choose a bright future; a chance to save our priceless natural and historic heritage.
